APPLICATION METHOD / TOOLS

Open the tube and pull Sika® Cleaning Wipes-100 wipes through the pre-cut opening. Use Sika® Cleaning Wipes-100 by scrubbing your hands with the abrasive side and wipe-off with the fine smooth side. Immediately after use, reseal container tightly.

LIMITATIONS

Sika® Cleaning Wipes-100 may not be used as a pretreatment for sealants or adhesives.
